1. <u>Companies Act and Company's Constitution</u>

Under the Company's Constitution, any notices or documents (including, without limitation, any accounts, balance sheet, financial statements or report) which is required or permitted to be given, sent or served by the Company, or by the Directors, to a member may be given, sent or served using electronic communications.

Therefore, any notice or document shall be deemed to have been duly given, sent or served upon transmission of the electronic communication as provided under the statutes or any other applicable regulations or procedures.

2. <u>Rules 1207 and 1208 of the Listing Manual Section B: Rules of Catalist (the "Catalist</u> <u>Rules") of the Singapore Exchange Securities Trading Limited (the "SGX-ST")</u>

Notwithstanding the use of electronic communications, the Company will continue to send the following documents to shareholders by way of physical copies:

- (i) forms or acceptance letters that shareholders may be required to physically complete;
- (ii) notices of meetings, excluding circulars or letters referred in that notice;
- (iii) notices and documents relating to takeover offers and right issues; and
- (iv) notices under Rules 1208 and 1209 of the Catalist Rules.

The annual report for the financial year ended 31 December 2023 (the "**Annual Report**") will be issued to shareholders through electronic communication. Any shareholder who wishes to request for a physical copy of the Annual Report should complete the request form in the package which will be mailed to them containing physical copies of the Notice of Annual General Meeting and proxy form. The Annual Report will be mailed to the relevant shareholders within 14 working days upon receiving the shareholder's request.

3. Rule 1209 of the Catalist Rules

With the implementation of the use of electronic communications, shareholders are to note that the Company will be making an announcement of the upcoming Annual General Meeting and making available the Annual Report on the following website from 12 June 2024 onwards:
